

## INVITATION TO BID

Low Income Housing Development Corporation of Terre Haute will receive sealed bids for the construction of 7 single-family houses on scattered sites in the City of Terre Haute, Indiana until 10:00 AM on the 2nd day of September, 2010 at the office of the Department of Redevelopment, City Hall, 17 Harding Ave., Room 301, Terre Haute, Indiana at which time and place all bids will be publicly opened and read aloud.

Bids will be received on the basis of a single lump sum and alternates for complete construction as described in the Instructions to Bidders. The work is to include all labor, materials, equipment, tools and appliances, transportation, all applicable taxes, permits and everything required for the entire performance and completion of the work in every detail.

All work shall be in strict accordance with this Invitation to Bid and the bidding Contract Documents as prepared by Sanders & Associates, Inc. Any bids received after the above specified time and date will be returned to bidders unopened. Bids shall be accompanied by the General Contractor's Proposal Contents as stated in the specifications.

Bidding and Contract Documents including Drawings and Specifications may be examined in the office of the architect, Sanders & Associates, Inc., 611 Deming St., Terre Haute, Indiana, 47807, (812) 232-5256, Fax – (812) 232-7156 and at the Dept. of Redevelopment, City Hall, 17 Harding Avenue, Room 301, Terre Haute, Indiana (812) 244-2393.

Plans and specifications will be available for distribution August 13, 2010. The plans and specifications must be purchased directly from Rapid Reproductions, 129 S. 11<sup>th</sup> St., Terre Haute, IN 47807, with no deposit required; however, anyone submitting a bid must register and pick up a bid packet from the architect's office, Sanders & Associates, Inc., 611 Deming St., Terre Haute, IN 47807. Only those who have registered and picked up a bid packet will receive addenda and/or written clarifications. Failure to register will be cause for rejection of any bid.

No bids shall be withdrawn for a period of sixty-(60) calendar days after the bid opening without written consent of the Architect.

Do not include sales tax in the bid amount. The owner is exempt from payment of Indiana Sales Tax and Use Tax. The owner will furnish the contractor with the necessary exemption number upon request.

A certified check or bank draft, payable to the order of Low Income Housing Development Corporation of Terre Haute, negotiable U.S. Government Bonds (at par value), or a satisfactory Bid Bond executed by the Bidder and acceptable surety, in an amount equal to five percent (5%) of the total amount of the bid shall be submitted with each bid.

Bid Guaranty will be returned to unsuccessful bidders upon selection of the successful bidder. Bid Guaranty of the successful bidder will be returned upon the signing of contracts. Bids may be held not to exceed sixty-(60) days from the date of Bid Opening for the purpose of reviewing the Bids and investigating the qualifications of the Bidders, prior to the award of a Contract.

Contractor receiving award shall furnish at the directive of the Owner, an approved Performance Bond, Labor and Material Payment Bond in an amount at least equal to 100% of the contract amount.

Attention is called to the fact that no less than minimum salaries and wages must be paid on this project and that the Contractor must insure that all employees and applicants for employment are not discriminated against because of their race, religion, color, sex, national origin, or individuals with handicaps. Women and Minority Owned Businesses qualified to perform the work contemplated by this solicitation are encouraged to bid.

The work to be performed under this contract is on a project assisted under a program providing direct Federal financing assistance from the Department of Housing and Urban Development and is subject to the requirements of Section 3 of the Housing and Urban Development Act of 1968, as amended, 12 U.S.C. 1701u, and Executive Order 11246 as amended.

Low Income Housing Development Corporation of Terre Haute does business in accordance with the Federal Fair Housing Laws and promotes fair housing in the community. It is illegal to discriminate against any person because of race, color, religion, sex, handicap, family status, or national origin; in the sale or rental of housing or residential lots, in advertising the sale or rental of housing, in the financing of housing, in the provision of real estate brokerage services, in the appraisal of housing, and blockbusting is also illegal.

The time completion of the project shall be 120 days after the notice to proceed. Low Income Housing Development Corporation of Terre Haute reserves the right to reject any or all bids or waive any informality in the bidding to the extent permitted by law.
